A. Tabled from the City Council Meeting on October 18<sup>th</sup>, 2021. Further discussion and possible approval for the recommendation from the Zoning Board from October 14<sup>th</sup>, 2021. The recommendation is not to approve Trinity Lutheran Church / Preschool, located at 533 W. Third Street, to install four-foot chain link fence ten feet north of their property line towards 4<sup>th</sup> Street. The City of El Paso Zoning Ordinance 315-20, B4 for supplement yard regulations allows fences to be installed on the property line, except for corner lots requiring 50 feet from the intersection. This property is zoned A-2 (Residential-Single Family-Older Development).
